










Forward Current Derating Curve

#### **REFLOW SOLDERING PROFILE for LEAD-FREE SMD PROCESS**



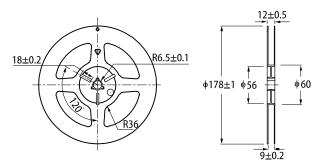


